## • School Updates - Director Abdulle

- School updates Enrollment, Staffing, and general operation:
  Director Abdulle, The enrollment projected target was 350, and we are around 300 enrolled. We are short of the target but making progress toward the projection target. Staff, All classroom teachers are filled; we still lack a few positions, such as ESL Teacher, Elective Teacher, (STEM) Math Intervention teacher, and SPED Teacher. Dr. Warfaa, Asked a question: What does it mean to not meeting the projected number? Director Abdulle, Said it will adjust; no worries regarding the budget for now. The Finance Direct said we have no concern with a strong fund balance school has and not even spend the ESSERs. That would not be an issue now. The Director and I will revise the budget and submit it to the board for approval in the October meeting. As well that not filling all the positions will be re-evaluated and make adjustments.
- Annual Report and <u>World Best WorkForce</u> committee Implementation: The World's Best work was waiting to hear from the MDE and next steps. The annual report is almost done and will be finalized before the next board meeting.

- School finance updates Joe and Abdi.
  - updates from the financial end of FY21 and starting FY22: The budget is working / operation under the budget that the board approved in May. We ended up strong this year. We have not spent the ESSERs, grants; We continue building a solid fund balance. And if we maintain what we have, we could end the year around fifteen percent of the fund balance. The director and I plan together with the best and appropriate to allocate the ESSERs funds.
